### **Planned Assessment Procedures**

By completing either of the Cocurricular Event Assessment forms (below), leaders will include key indicators of the effectiveness of each cocurricular event or program based on their program goals.

The Assessment Committee Chairperson, with assistance from the Institutional Research office, will compile and summarize the cocurricular assessment data during the summer months. This information will be included in annual assessment reports, and shared with cocurricular leaders by the start of the fall semester to inform decisions and promote improvement.
