Consortium Agreement Information

Rose State College's Financial Aid Consortium Agreement allows students who are enrolled at RSC and taking courses at other eligible institutions to receive funding for the combined enrollment. Courses taken at eligible institutions should apply to the degree the student expects to receive from RSC. Students should seek assistance from Academic Advisors to determine if classes will apply to their degree plan. **Students must notify RSC if he/she drops the course(s), withdraws, stops attending, or changes enrollment at the other institution at any time during the semester.** As stated in the RSC Academic Progress Policy, academic progress is reviewed every semester; therefore it is the student's responsibility to provide the Rose State College Financial Aid Office and the RSC Office of Admissions and Records his/her transcript from the eligible institution at the end of the semester. Financial Aid funds for the following semester will not be disbursed until these grades have been submitted and reviewed.

Procedures for obtaining a RSC Consortium are as follows:

- Complete Section I of the attached RSC Consortium agreement and attach a copy of your enrollment from the eligible institution.
- Have Section II of the agreement certified by the required parties at the eligible institution.
- Return completed form with the eligible institution's enrollment verification to the Rose Financial Aid Office.

Eligibility Requirements:

- Student must be seeking a degree from RSC.
- Student CANNOT be degree seeking at the eligible institution.
- For Federal Pell Grant eligibility, a student must be enrolled in at least 6 credit hours at RSC during the fall and/or spring semester or 3 hours during the summer semester.
- For Federal Direct Loan eligibility, a student must be enrolled in at least 6 credit hours at RSC during the fall, spring or summer semesters.
- To be honored the RSC Consortium Agreement must be completely certified by the eligible institution and have enrollment attached.
- Incomplete forms will be returned to the student for completion.
