Federal regulations specify certain aggregate loan limits for undergraduate borrowers. Specifically an undergraduate **dependent** student can borrow a maximum of \$31,000 with no more than \$23,000 in subsidized loan funds while an undergraduate **independent** student can borrow a maximum of \$57,500 with no more than \$23,000 in subsidized loan funds.

Based on data provided by the National Student Loan Data System, you may have received federal loan funds in excess of or close to the loan limits established by the Department of Education. Because your loan debt is close to these limits, our office would like to assist you in planning your future loan borrowing.

Your educational plans may involve finishing your associate's degree here at RSC and/or continuing with the pursuit of a bachelor's degree at another college and you will likely need to rely on Federal Direct Loans to meet the cost of this continued education. It is imperative for you to understand your current loan debt and remaining loan eligibility in order to make wise decisions for your future.
