Ticket to Rose Checklist 2025 High School Graduates

Initial eligibility requirements:

- ☐ Students who have never attended Rose State College must submit an Application for Admission to Rose State College at rose.edu/apply. Concurrent students do not need to submit a new application for Admissions.

Make sure that you:

- List the high school that you will graduate from on the application.
- Declare a major (All Ticket to Rose students must declare a major).

- ☐ Complete the 2025-2026 Free Application for Federal Student Aid (FAFSA) at studentaid.gov (Opened October 1st, 2024). Include the Rose State College School Code (009185) when prompted.

- ☐ Class of 2025 graduates from a ***private, alternative, virtual or home school***, whose custodial parent's residence is located in the Carl Albert, Choctaw, Del City, Midwest City or Star Spencer school district must verify residency in an eligible district. To verify, scan a recent copy of a utility bill in your custodial parent's name, save it in PDF format to your computer and email as an attachment to tickettorose@rose.edu.

- ☐ Students should seek academic advisement through the Office of Enrollment Management, Student Services Building 100 (Enrollment begins April 7, 2025). Students must enroll in a minimum of 9 credit hours for the fall 2025 semester. *Ticket to Rose funding for class of 2025 is not available for the summer 2025 session.*

- ☐ To apply for the Ticket to Rose Scholarship you must submit your official final high school transcript with date of graduation. Transcripts must meet the required 2.5 weighted GPA standard. You can request an official final transcript from your high school guidance counselor. They may be sent electronically, or by mail to: Rose State College, Office of Admissions and Records, 6420 SE 15th Street, Midwest City OK 73130.

There is no separate Ticket to Rose Scholarship Application.

Once enrolled, the student MUST complete their Financial Aid file for final eligibility determination:

Log in to the Rose State College student information system at sso.rose.edu.

Your **User ID** is your first and last initial, capitalized, followed by your Rose State College student ID#
(Example: John Smith-whose student ID is 0123456=JS0123456)

First time students select “First Time Users” for your first login and password setup.

Concurrent students select “Returning Users” to change your password from the previous MMDDYY setup.

Click **Student OASIS** to find your Dashboard, then expand the **My Information** section to find your **To-do list** and **Message Center**. Click on each item on the **To-do list**, and a message will appear that will explain the steps necessary to complete that requirement. MPN and loan entrance **To-do list** items are not required. SAT and ACT scores are also not required, but should be turned in to the Admissions Office for placement purposes.

Requested Financial Aid documents must be turned in by the last day of the fall 2025 semester..

To remain eligible for future semesters, Ticket to Rose students must:

- Maintain **Satisfactory Academic Progress**, as defined in the Rose State College Financial Aid [Satisfactory Academic Progress Policy](#) .
- Enroll in a minimum of **nine (9) credit hours** for each fall and spring semester. Summer enrollment is optional and funding is available should the student enroll in a minimum of **three (3) credit hours**.
- Renew your **FAFSA** each new academic year at studentaid.gov and include the Rose State College school code 009185 (Opens October 1st each aid year).
- Provide all requested information requested on your **Message Center, To-do List** and **Rose E-mail**.
