# RETIREE OPTION PERIOD MEETING SCHEDULE PLAN YEAR 2024



**Attending a meeting is optional. If you do not have any changes to your coverage, you do not need to attend a meeting or return your Option Period form.**

The OMES Employees Group Insurance Division will conduct virtual webinar meetings and host benefit fairs to assist with the annual Option Period enrollment process. During the virtual webinars, representatives will present information on the health, dental, vision and life plans.

**Benefit fairs will be held in seven convenient locations across the state** for members who wish to get additional in-person information. These are come-and-go events and will not include a formal presentation. Plan representatives will be available to answer your Option Period questions.

### **Choose the right meeting for you.**

If you currently have Medicare or will gain Medicare eligibility in 2024, you have three different virtual meeting options or you may attend one of the benefit fairs in your area. One virtual meeting outlines all of the health, dental, vision and life plans. The other two shorter virtual meetings divide the plan presentations: one outlines the health and life plans, and the other outlines the dental and vision plans.

EGID will conduct two special meetings for members who will age-in or gain Medicare in 2024.

Members under age 65 and not currently eligible for Medicare are invited to attend one of the Pre-Medicare virtual meetings.

## **GAINING MEDICARE IN 2024** **2 p.m. on Nov. 8 and on Nov. 29**

Specifically designed for those members that will gain Medicare eligibility during 2024 and will discuss the different parts of Medicare, the timeline of when to enroll in Medicare benefits and the main differences between a Medicare supplement and Medicare Advantage Prescription Drug plan. Plan presentations will not be included in this meeting. Time limit – 60 minutes.

## **MEDICARE – ALL PLANS** **10 a.m. on Nov. 8 and Nov. 29**

Representatives will present the Medicare supplement plans and the Medicare Advantage Prescription Drug plans available for Plan Year 2024. Dental, vision and life plan representatives will also present. Time limit – 2.5 hours.

## **MEDICARE – HEALTH AND LIFE ONLY** **10 a.m. on Nov. 1 and Nov. 15**

Includes presentations covering the Medicare supplement plans and Medicare Advantage Prescription Drug plans available for Plan Year 2024, along with information on the HealthChoice Life insurance program. Time limit – 90 minutes.

## **MEDICARE – DENTAL AND VISION ONLY** **2 p.m. on Nov. 1 and Nov. 15**

Dental and vision plan representatives will present the benefits of each plan. Time limit – 90 minutes.

## **PRE-MEDICARE** **10 a.m. on Nov. 3 and Nov. 17 and at 2 p.m. on Nov. 27**

Includes information on the pre-Medicare plans available for 2024 and presentations from the health, dental, vision and life plans. Time limit – 90 minutes.

## OPTION PERIOD REMINDERS

### OPTION PERIOD FORMS

Your personalized Option Period Enrollment/Change Form will be mailed to you before the meetings. Option Period materials are available at [Oklahoma.gov/omes](http://Oklahoma.gov/omes). Forms with changes must be returned, postmarked by Dec. 7, 2023. **If you do not have changes to your benefits, you do not need to return your form.**

### Pre-Medicare HealthChoice plan members, your action is required!

If you or your dependents are enrolled in the pre-Medicare HealthChoice High or Basic Plan and are not tobacco users, you will need to complete the Tobacco-Free Attestation on the HealthChoice website at [HealthChoiceOK.com](http://HealthChoiceOK.com). If you do not or cannot attest to being tobacco-free for yourself or your covered dependents, you will be moved to an alternative plan with a higher deductible for 2024. This does not apply to HealthChoice Medicare members.
